**ARTICLES OF ORGANIZATION
OF

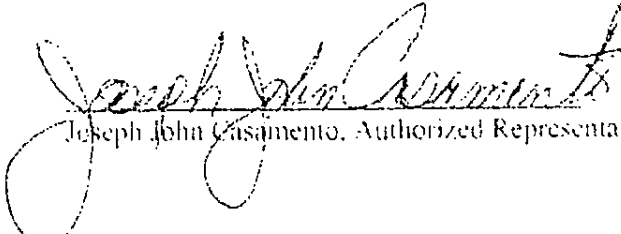
ARTICLE IV – MANAGEMENT OF THE COMPANY

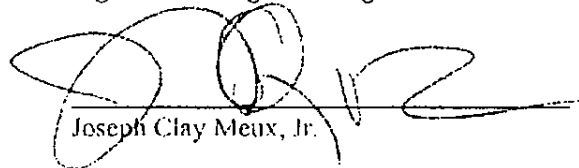
