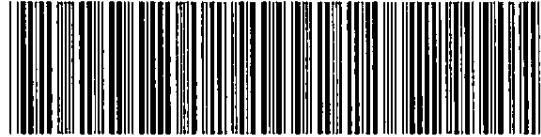

Restrictions on Membership

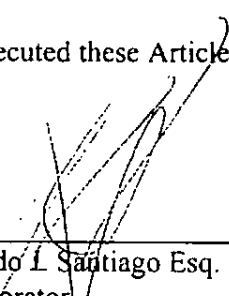
ARTICLE VIII

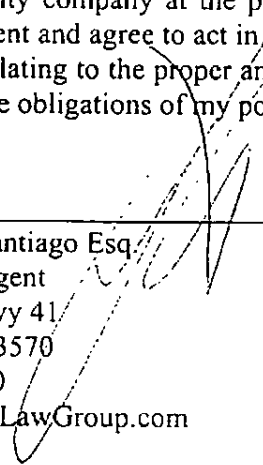
