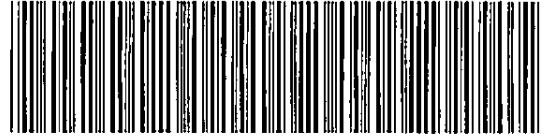

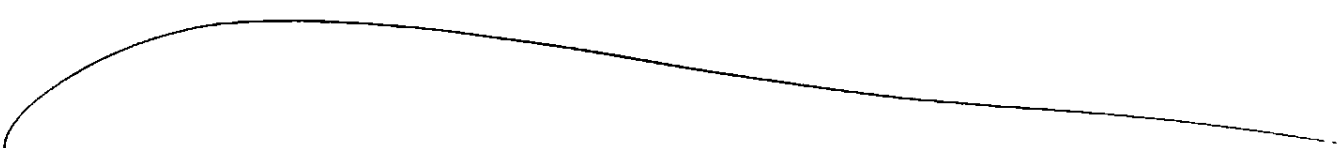

ARTICLES OF ORGANIZATION

OF

The Company shall be member-managed in accordance with the Operating Agreement of the Company as adopted and agreed upon by the members.

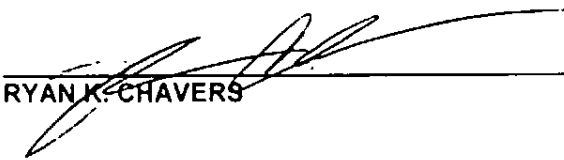
ARTICLE X – AMENDMENT

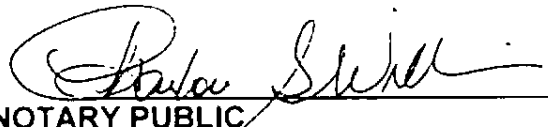

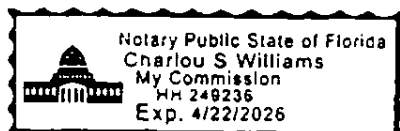
