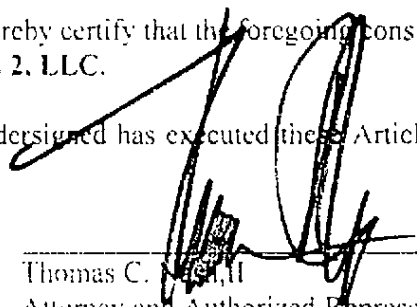
ARTICLE VII

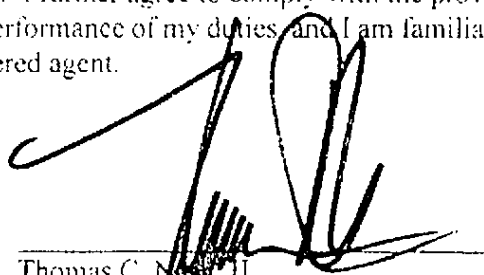
