
**ARTICLE VII**  
**NEW MEMBERS**



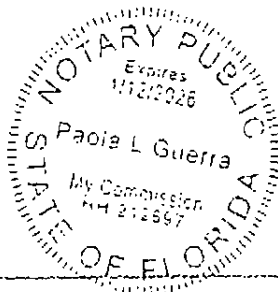
