**ARTICLES OF ORGANIZATION
OF
STMARYS2900, LLC**

Pursuant to §605.0201 of the Florida Revised Limited Liability Company Act, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I
NAME**

The name of the limited liability company is StMarys2900, LLC (the "Company").

**ARTICLE II

MANAGEMENT OF THE COMPANY**


The Company will be managed by its sole manager in accordance with and subject to the requirements of the Act and the Operating Agreement of the Company. The name and address of the manager of the Company is:
