

ARTICLES OF ORGANIZATION OF APOLLO SHIP CHANDLER NO. 22 SUBSIDIARY LLC

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act. Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Apollo Ship Chandler No. 22 Subsidiary LLC (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address office of the Company is 6950 NW 77th Court, Mami, FL 33166.
