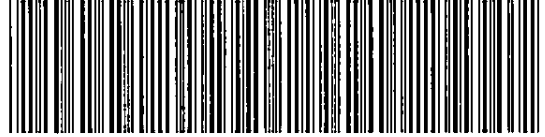

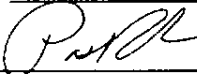

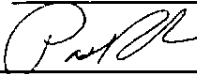

The name and street address of the initial registered agent of the Company are Cogency Global Inc., 115 North Calhoun Street, Suite 4, Tallahassee, Florida 32301

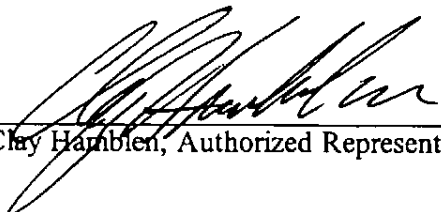
ARTICLE V. MANAGEMENT
