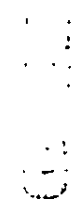
**ARTICLE IV.




ARTICLE VI.
