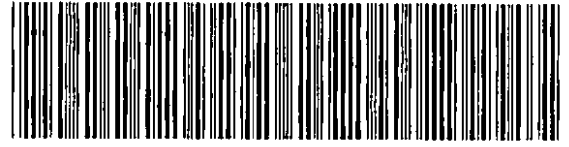


ARTICLE IV.


