ARTICLE II - PRINCIPAL OFFICE

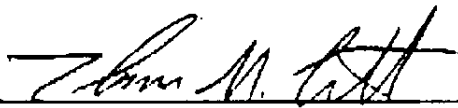
The mailing address and street address of the principal office of the Company is 1107 Aruba Drive, Orlando, Florida 32806.
