## ARTICLE I - NAME

The name of the Limited Liability Company is XY-LM4756, LLC.

## ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is 2736 Pinehurst Drive, Weston, FL 33332.

## ARTICLE III - DURATION

The period of duration for the Limited Liability Company shall be perpetual.

## ARTICLE IV - MEMBER UNITS

The Limited Liability Company is authorized to issue 1,000 Units of membership interest, which Units shall evidence the interest of the members of the Limited Liability Company, which Units shall be designated "Member Units." The number of members of the board of managers may be either increased or diminished from time to time as provided in the Operating Agreement of the Limited Liability Company but shall never be less than one (1). #### ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

#### ARTICLE VIII - WITHDRAWAL; RETURN OF CAPITAL

The Members of the Limited Liability Company shall have the right to withdraw as a member with (i) six (6) months prior notice, and (ii) with the consent of Members owning one hundred (100%) percent of the Member Units of the Limited Liability Company. Likewise, there shall be no return of all or a portion of the contributed capital without the consent of Members owning one hundred (100%) percent of the Member Units of the Limited Liability Company.
