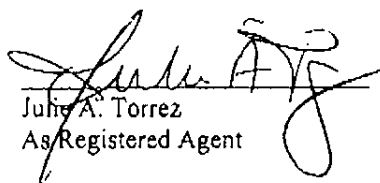

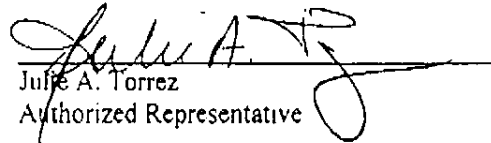
ARTICLE V
