**ARTICLES OF ORGANIZATION  
OF

The undersigned, being a duly authorized representative of the member (the "Member") of Loud And Live Talent, LLC (the "Company"), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**
