ARTICLES OF ORGANIZATION
OF
WINDS ENERGY PH INVESTMENTS USA, LLC



The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under Chapter 605 of the Florida Statutes, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is Winds Energy PH Investments USA, LLC.

SECOND: The Limited Liability Company shall continue until the occurrence of an event set forth in the Operating Agreement which causes the termination of the Limited Liability Company.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with Chapter 605 of the Florida Statutes, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The mailing address and street address of the initial registered agent office of the Limited Liability Company in Florida is 1420 Celebration Boulevard, Suite 200, Celebration, Florida 34747, and the name of the initial registered agent of the Limited Liability Company in Florida at that address is Jorge A. Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 605, Florida Statutes.

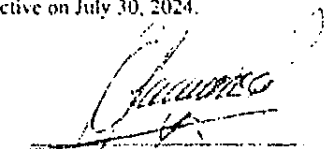
