ARTICLES OF ORGANIZATION OF

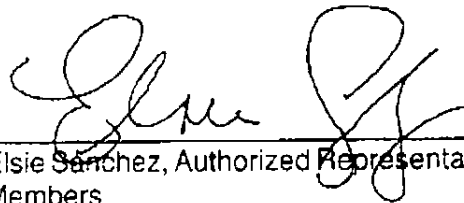

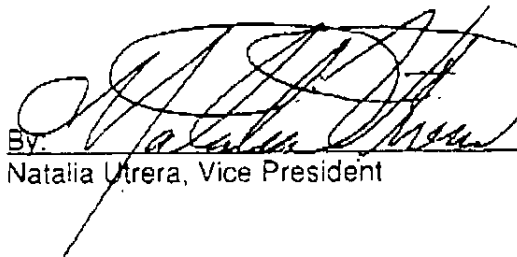
