The Company's existence shall commence effective as of December 20, 2024, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

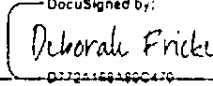

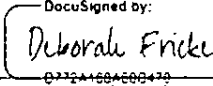
