ARTICLE IV – MANAGEMENT

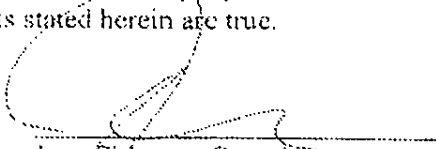

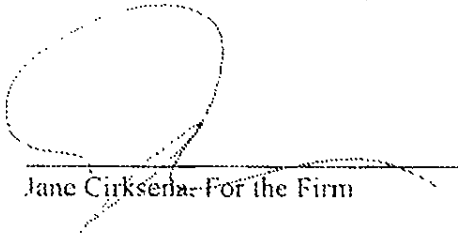
