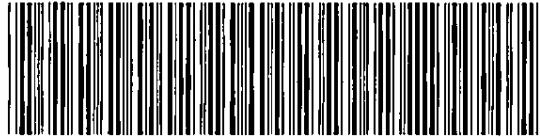

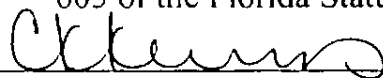

The LLC will be manager-managed.

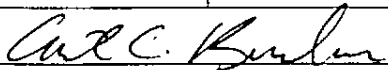

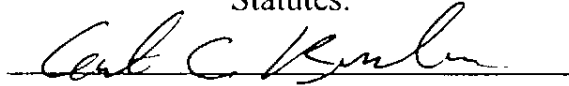
