The Company's existence shall commence effective as of January 1, 2025 and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

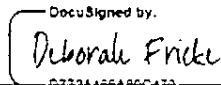
**ARTICLE IV

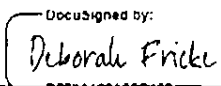
