These Articles of Organization shall be effective January 2<sup>nd</sup> 2025.

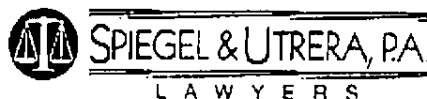
**ARTICLE 4 - DURATION**




