


## **PLAN OF MERGER**

This Plan of Merger (the "Plan") is entered into as of [date] by and between **Patzer LLC**, a Georgia limited liability company ("Patzer LLC"), and **Mobile Card Games & Travel Apps LLC**, a Florida limited liability company ("Mobile Card Games & Travel Apps LLC"), pursuant to the applicable laws of the States of Georgia and Florida.

### **1. Parties to the Merger**

- **Acquired Entity:** Patzer LLC, organized under the laws of the State of Georgia, with its principal place of business at [address].
- **Surviving Entity:** Mobile Card Games & Travel Apps LLC, organized under the laws of the State of Florida, with its principal place of business at [address].

### **2. Ownership**

The undersigned, Michael Patzer, is the sole member and 100% owner of both Patzer LLC and Mobile Card Games & Travel Apps LLC.

### **3. Terms of the Merger**

- Effective upon the filing of the required documents with the Secretaries of State of Georgia and Florida, Patzer LLC will merge into Mobile Card Games & Travel Apps LLC, with Mobile Card Games & Travel Apps LLC continuing as the surviving entity.
- All rights, privileges, properties, assets, debts, obligations, and liabilities of Patzer LLC shall be transferred to, vested in, and assumed by Mobile Card Games & Travel Apps LLC.

### **4. Conversion of Interests**

- The membership interests in Patzer LLC held by the sole owner shall be canceled upon the merger. No new membership interests will be issued in Mobile Card Games & Travel Apps LLC as a result of the merger, as the sole owner remains unchanged.

### **5. Effectiveness of the Merger**

- The merger shall become effective upon the filing of the Articles of Merger with the Florida Department of State and any necessary filings with the Georgia Secretary of State.

### **6. Dissolution of Patzer LLC**

- Upon the effectiveness of the merger, Patzer LLC will cease to exist as a legal entity under Georgia law. Articles of Dissolution will be filed with the Georgia Secretary of State as required by Georgia law.


## **7. Governing Law**
