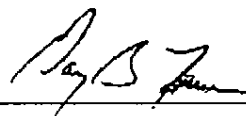
**ARTICLE IX - ADOPTION OF OPERATING AGREEMENT**

**ARTICLE X - AMENDMENT**

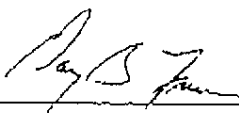
The Company shall have the power to amend or supplement these Articles of Organization when approved by majority vote of the members.
