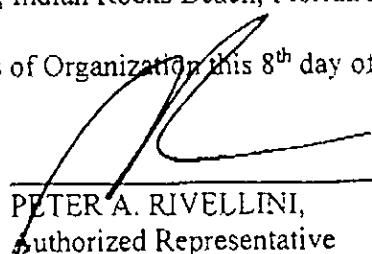
**ARTICLE III
