NAME

### PROPERTY

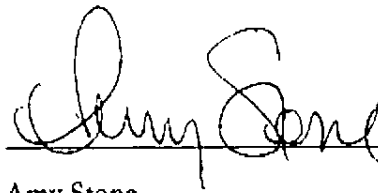

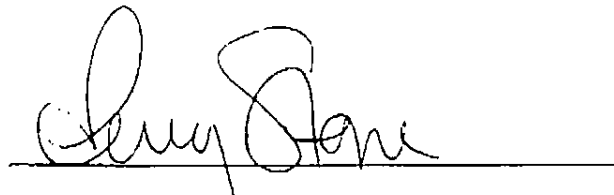
