The power to adopt, alter, amend or repeal an Operating Agreement governing the operation of the Company shall be vested in its members.


ARTICLE V

IN WITNESS WHEREOF, the undersigned authorized representative of the initial members has executed these Articles of Organization this 10th day of January, 2025.




