This letter is to inform you about Doggibags Inc. That was my corporation/business from 1980 until I just dissolved it on December 31, 2024. Doggibags Inc was located at 601 W Main St in Leesburg from 1983 until I dissolved it last month.

I am now 83 years old and decided, along with my accountant, to downsize from a corporation to a sole proprietorship to simplify my business filings. So, I moved the shop to a smaller venue at 103 S 6th St in Leesburg (right around the corner) in the same building, and restructured to a single-member LLC using as similar a business name as possible.

I DO NOT ever plan to re-open Doggibags Inc, therefore I have no intention of revoking the dissolution. I release the name (to myself, in essence) to continue business under the new name Doggibags LLC for as long I can and until I choose to retire, with your approval.
