ARTICLE II - PRINCIPAL OFFICE

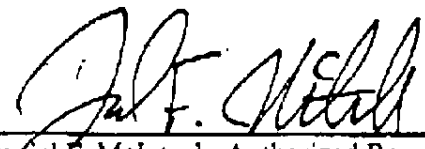
The mailing address and street address of the principal office of the Company is 13480 Panama Beach Ct., Orlando, Florida 32828.

ARTICLE IV - AUTHORIZED REPRESENTATIVE

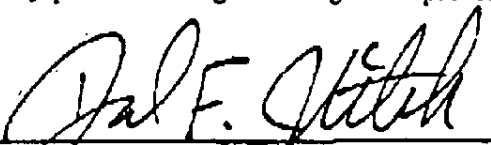
