

ARTICLES OF ORGANIZATION OF KLP GINGER CYBERSECURITY LLC

The undersigned, acting as the authorized representative of KLP Ginger Cybersecurity LLC (the "Company"), does hereby certify that said authorized representative has formed the Company to be a limited liability company under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended (the "Act"), and, pursuant to the Act, hereby sets forth the following Articles of Organization:
