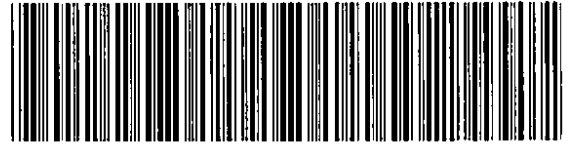

ARTICLES OF ORGANIZATION

OF

K & E COLLECTIVE, LLC

THE UNDERSIGNED, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "Act"), hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **K & E COLLECTIVE, LLC** (hereinafter called "Company"). The principal place of business of the Company in Florida shall be in Hillsborough County.

ARTICLE V - REGISTERED OFFICE AND AGENT

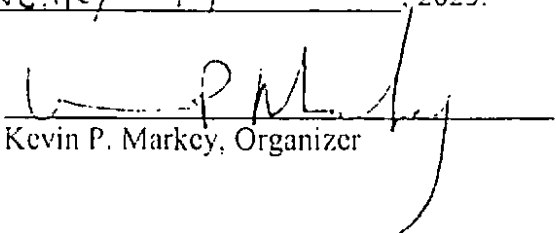

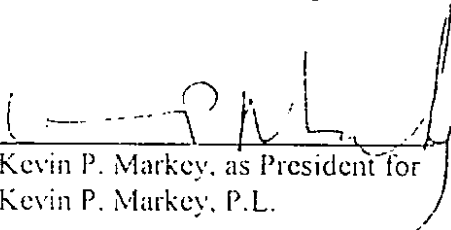
