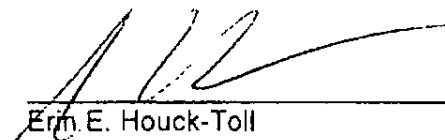
**ARTICLE VI-MANAGEMENT OF THE COMPANY**
