

ARTICLES OF ORGANIZATION OF

STM STRATEGIES, LLC, a Florida limited liability company

The undersigned, acting as the Manager of STM Strategies. LLC (the "Company"), does hereby certify that said Manager has formed the Company to be a limited liability company under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605. Florida Statutes, as amended (the "Act"), and, pursuant to the Act, hereby sets forth the following Articles of Organization:

ARTICLE I: NAME

ARTICLE II: ADDRESS AND PLACE OF BUSINESS
