The street address and the mailing address of the principal office of the Company are 261 Roaring Brook Drive, St. Augustine, Florida 32084.

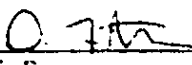
ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

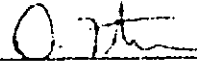
