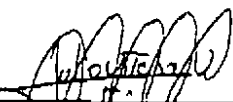
ARTICLE X

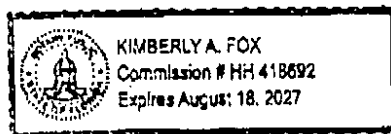

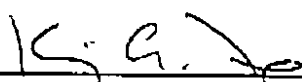
