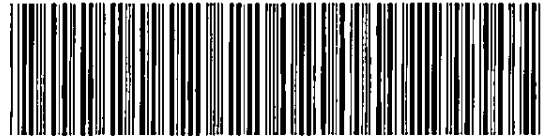

ARTICLES OF ORGANIZATION

PEACE & HARMONY FOUNDATION, LLC

These Articles of Organization ("Articles") are adopted, effective this 17th day of January 2025, pursuant to Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "Act"). The undersigned sets forth the following:

ARTICLE I - NAME

The name of the Limited Liability Company is PEACE & HARMONY FOUNDATION, LLC (the "LLC").

ARTICLE II - ADDRESS

The mailing address and principal office of the LLC is: 2032 Southside Blvd, Jacksonville, FL 32216.

ARTICLE III - MEMBERSHIP AND FORM OF MANAGEMENT

The LLC shall be member-managed within the meaning of Section 605.0407, Florida Statutes, and have a single member consisting of Peace & Harmony Foundation, Inc., a Florida nonprofit corporation (the "Member"). The LLC shall not admit any additional members. The LLC shall be governed by the Act, these Articles, and the Operating Agreement.

ARTICLE IV - PURPOSE

The purpose of this LLC is to further the charitable and educational purposes of its member. The LLC qualifies for derivative tax-exempt status as a disregarded entity within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code"), by virtue of its relationship with the Member. The LLC also qualifies through its exempt status relationship derived from its Member as a charitable organization for purposes of receiving deductible gifts and grants within the meaning of Section 170(b)(1)(A) of the Code.

The LLC shall engage in any lawful activity for which limited liability companies may be organized under Florida law and are not prohibited by these Articles, the Operating Agreement, or the Code. However, no activities that would jeopardize the Member's tax-exempt status or conflict with its classification as a 501(c)(3) organization shall be permitted.

1. Affiant Information:

My name is Isaac Akin, and I serve as the Vice President of Peace & Harmony Foundation, Inc., and as the sole member of Peace & Harmony Foundation, LLC.

2. Entity Relationship:
