**ARTICLES OF ORGANIZATION
OF

The undersigned, Wayne J. Garcia II, a natural person competent to contract and an authorized representative of a member of OnPoint Pensacola, LLC, hereby presents these Articles of Organization as the Articles of Organization of OnPoint Pensacola, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is OnPoint Pensacola, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street and mailing address of the Company's initial principal office is 1703 Lewis Turner Boulevard, Fort Walton Beach, Florida 32547. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

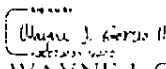
