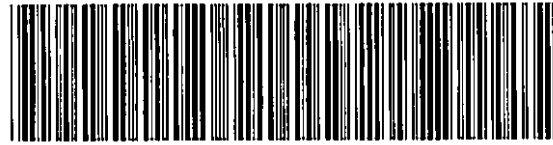

The mailing address and street address of the principal office of the Company shall be 19667 Turnberry Way, Unit PH GR, Aventura, Florida 33180.

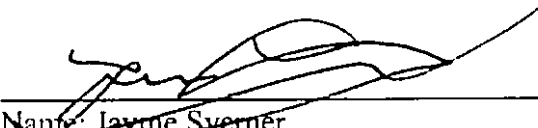
**ARTICLE III. REGISTERED AGENT AND OFFICE**
