ARTICLES OF ORGANIZATION OF TNSA INVESTMENTS LLC

A Florida Limited Liability Company pursuant to Chapter 605, Florida Statues

ARTICLE I - NAME

<u>ARTICLE VIII – AMENDMENT</u>

These Articles of Organization may be amended in accordance with the Florida Limited Liability Company Act.

ARTICLE IX - MEMBERS RIGHT TO CONTINUE BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in this Company, the remaining members shall have the right to continue the business provided there is at least one remaining member.

ARTICLE X - DISSOLUTION

This Company may be dissolved at any time on the affirmative vote of at least two thirds (2/3) of majority of the members of this Company entitled to vote thereon. On dissolution, the Company's property and assests shall, after payment of all debts of the Company, be distributed to the members according to the preceding contribution od each one to the capital of this Company.
