#### ARTICLES OF ORGANIZATION

#### OF

### ATLANTIC SEMICONDUCTOR, LLC

- 1. Name. The name of this limited liability company is ATLANTIC SEMICONDUCTOR, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida (the "Act").
- 2. <u>Duration</u>. The Company's existence shall be perpetual, and the effective date of commencement of the Company's existence shall be February 7, 2025.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all <u>lawful</u> activities and businesses that may be conducted by a limited liability company under the laws of Florida.
