I hereby provide my consent to the filing and formation of Flight Blue, LLC as a Florida limited liability company, even though it has the same name as Flight Blue, Inc.

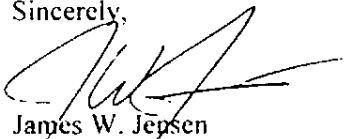

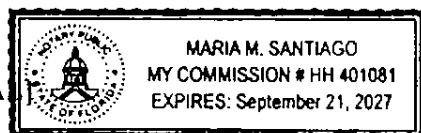
