**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is **THE JOKER'S WILD, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The mailing address and the physical address of the Company's principal office is **5111 66th Street N., St. Petersburg, Florida 33709.**

6. Purpose; Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
