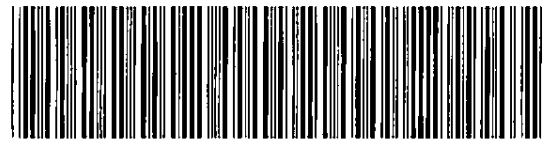

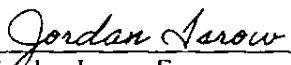

PLAN OF CONVERSION/DOMESTICATION

January 10, 2025

WHEREAS, Lewis Consulting, LLC, a New Jersey limited liability company (“the “Company”) with business identification number 0450295248, plans to convert into a Florida limited liability company, subject to approval by the Manager and Member of the Company, the filing of the Florida Articles of Conversion (“FL Articles of Conversion”) and the Florida Articles of Organization (“FL Articles of Organization”) with the Department of State of the State of Florida and the filing of a Statement of Surrender (“Statement of Surrender”, and collectively, with the FL Articles of Conversion, and the FL Articles of Organization, may be referred to herein as the “Conversion Filings”) with the State of New Jersey Treasury, Division of Revenue and Enterprise Services; and

WHEREAS the Florida Revised Limited Liability Company Act and the New Jersey Revised Uniform Limited Liability Company Act, require the Company to adopt a Plan of Conversion/Domestication;

NOW, THEREFORE, the Company hereby sets forth the details for such conversion into B Lewis Consulting, LLC, a Florida limited liability company (the “FL Company”), in this Plan of Conversion:

1. The Company shall convert the Company to a Florida limited liability company (the “Conversion”) to be known as “B Lewis Consulting, LLC” and to perform such acts and execute such documents as may be necessary and convenient to affect the Conversion, including but not limited to:
 - a. The execution of the FL Articles of Conversion together with the FL Articles of Organization, in substantially the forms of Exhibit A and Exhibit B respectively, attached hereto and made a part hereof; and
 - b. The execution of the Statement of Surrender and Articles of Domestication in substantially the form of Exhibit C and Exhibit D, respectively, attached hereto and made a part hereof; and
2. Upon the filing of the Conversion Filings, each membership interest of the Company outstanding immediately prior to the conversion shall, by virtue of the conversion and without any action on the part of the holder thereof, be converted into the right to receive an equivalent membership interest in the FL Company.
3. The business of the Company shall continue to be carried on after the Conversion in accordance with the provisions of the Florida Revised Limited Liability Company Act, including Section 605.1046, the FL Articles of Organization, and any operating agreement adopted.
4. Upon the Conversion Filings, the Company has adopted the operating agreement attached hereto as Exhibit E.
