The mailing address and street address of the principal office of the Company is 4779 Collins Avenue, Apt. 3102, Miami Beach, FL 33140.

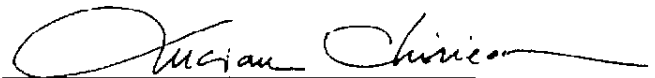
ARTICLE III – Management

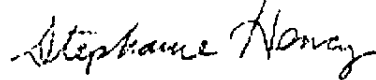
