ARTICLES OF ORGANIZATION GLOBAL ARTS PTO, LLC

These Articles of Organization ("Articles") are adopted and effective this 16th day of January, 2025, pursuant to Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "Act"). The undersigned sets forth the following:

ARTICLE I NAME

The name of the Limited Liability Company is Global Arts PTO, LLC (the "LLC").

ARTICLE II ADDRESS

The mailing address and principal office of the LLC is: 4660 Lusso Lane, Jacksonville, Florida 32246.

ARTICLE III MEMBERSHIP FOR PURPOSES OF CHAPTER 605, FLORIDA STATUTES, AND FORM OF MANAGEMENT

The LLC shall be Manager-Managed within the meaning of Section 605.0407, Florida Statutes, by a Board of Managers (referred to herein as the "PTO Board" or the "PTO Board of Managers"). For purposes of the Act, the LLC will have a single member consisting of Global Leadership Academy, Inc., a Florida nonprofit corporation (the "Member") and an organization exempt from taxation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986 or a related section of a successor statute (the "Code"). The LLC shall not admit any additional members at any time. The LLC shall be governed by the Act, these Articles, and the Operating Agreement, of even date herewith.

ARTICLE IV PURPOSE

The purpose for which this LLC is organized is to further the charitable and educational purposes of its Member, specifically, without limitation, to serve as the parent and teacher organization for the Global Leadership Academy Global Arts Campus. The LLC will also qualify for derivative tax-exempt status as a disregarded entity within the meaning of Section 501(c)(3) of the Code and 26 CFR Section 301.7701.3(a), by virtue of its relationship with the Member. The LLC will also qualify through its exempt status relationship derived from its Member as a charitable organization for purposes of receiving deductible gifts and grants within the meaning of Section 170(b)(1)(A) of the Code, and to engage in any lawful act or activity for which limited liability companies may be organized under Florida law and are not otherwise prohibited by these Articles of Organization, the LLC's Operating Agreement or the Code. However, nothing herein shall be construed as allowing any activities which would jeopardize the Member's tax-exempt status or otherwise be inconsistent with the Member's classification as an organization described

in Section 501(c)(3) of the Code and its regulations as they now exist or may hereafter be amended, or as a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

ARTICLE V INITIAL PTO BOARD OF MANAGERS
