The street and mailing address of the principal office of the Company is: 66 W Flagler Street Suite 900 #10640 Miami, FL 33130.


ARTICLE III. REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE IV. MANAGEMENT


The Company is to be manager-managed. The names of the initial managers are: Alexander D. Morales and Lisbeida E. Arenas.
