ARTICLES OF ORGANIZATION

OF

ARTICLE I - Name:

ARTICLE VII - Amendments:

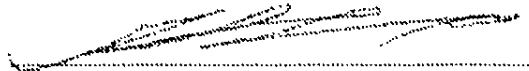
The Company reserves the right to amend any provision of these Articles of Organization.
