The undersigned, Cameron S. Price, hereby presents these Articles of Incorporation as the Articles of Incorporation of Stalker Ventures, Inc. pursuant to Chapter 607, Florida Statutes.

**ARTICLE I - NAME**

The name of the corporation is Stalker Ventures, Inc. This corporation is referred to in these Articles of Incorporation as the "Corporation."

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the principal office of the Corporation is 17361 Perdido Key Drive, Pensacola, Florida 32507.

**ARTICLE III - PURPOSE AND POWERS**

The Corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States. The Corporation shall have all powers that may now or hereafter be lawful for a corporation to exercise under the Florida Business Corporation Act.

**ARTICLE IV - CAPITAL STOCK**

The Corporation is authorized to issue ten thousand (10,000) shares of common stock with \$0.01 par value per share.

The date for commencement of the Corporation's existence shall be the date these Articles of Incorporation are filed with the Florida Department of State. The Corporation shall have perpetual existence.

**ARTICLE VI – INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE VII - OFFICERS**

The Corporation shall have such officers consisting of a President and such other officers as the shareholders of the Corporation shall in their discretion determine necessary or appropriate.


