## ARTICLES OF INCORPORATION OF JAMS WHOLESALE DISTRIBUTION SERVICES, INC.

#### ARTICLE I <u>Name</u>

The name of the corporation is JAMS Wholesale Distribution Services, Inc. (the "Corporation").

## ARTICLE II Principal Office

The address of the principal office and the mailing address of the Corporation is 4341 Lyons Technology Park, Unit 25, Coconut Creek, FL 33073.
