ARTICLES OF INCORPORATION OF THE ACCESS TO JUSTICE FOUNDATION OF NORTH FLORIDA, INC.

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - Name

The name of the Corporation shall be The Access to Justice Foundation of North Florida, Inc. (the "Corporation").

ARTICLE II - Principal Office and Mailing Address

The location of this corporation shall be at 2119 Delta Boulevard, Tallahassee, Florida, 32303 or at such other places within Florida as the Board of Directors may from time to time select and so communicate to the office of the Secretary of State of Florida.

ARTICLE III - Purpose

- A. The general nature of the objects and purposes of this corporation shall exclusively be, in accordance with the requirements of Section 501(c)(2) of the Internal Revenue Code of 1986, as amended (the "Code") to hold title to property, collect income therefrom, and turn over the entire amount thereof, less expenses, to its parent organization, Legal Services of North Florida, Inc., a Florida not for profit corporation, which itself is exempt under Section 501 of the Code, or the qualifying successor thereof.
- B. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to any member, officer or director of this corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes).
- D. The corporation shall distribute its income for each taxable year, at least annualty; at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code, or corresponding provisions of any subsequent federal tax laws.
- E. The corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code, or corresponding provisions of any subsequent federal tax laws; nor retain any excess business holdings as defined in Section 4943(c) of the Code, or corresponding provisions of any subsequent federal tax laws; nor make any investments in such manner as to incur tax liability under Section 4944 of the Code, or corresponding provisions of any subsequent federal tax laws; for make any taxable expenditures as defined in Section 4945(d) of the Code, or corresponding provisions of any subsequent federal tax laws.
- F. Notwithstanding any other provisions of this certificate, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(2) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended, or by an organization contributions to which are deductible under

Section 170(c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.

ARTICLE IV - Shares

The authorized number of shares of stock is: 100, par value \$0.01.

ARTICLE V - Term of Existence

The effective date upon which the Corporation shall come into existence shall be the date of filing of these Articles, and it shall exist perpetually thereafter unless dissolved according to law.

Such By-Laws may be made, amended, altered or rescinded from time to time, in whole or in part, by a majority vote of the members of the Board of Directors of this corporation present at any meeting of the directors duly called and convened at which a quorum is present, provided that a reasonable advance notice of the proposed action regarding the By-Laws shall have been given in writing to each director prior to such meeting.

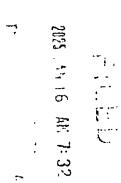
ARTICLE X - Dissolution
