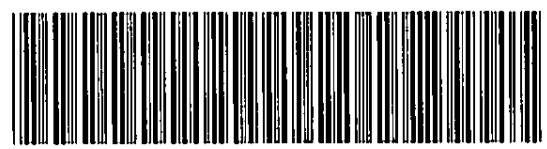



(a) The private property of the Stockholders shall not be subject to the payment of any corporate debts to any extent whatsoever.


(b) Subject to the provisions and conditions of this Article, the Corporation shall have
